# Stated Meeting of Presbytery de Cristo August 15, 2015

### **CALL TO ORDER**

## 1. Ministry for Leadership Report

## Actions taken at the March 25, 2015 meeting

In an action taken while convened as the Trustees of the Presbytery, approved permission for MFA to continue investigation of unburdening the Presbytery of the House of Neighborly Service property.

Authorized Brad Munroe and Bob Schulz, in response to a letter from Faith Presbyterian Church in Sierra Vista, to send a letter to Gradye Parsons on behalf of the Presbytery expressing concern regarding the actions of GA.

# Actions taken at the April 29, 2015 meeting

Approved the proposed Memorandum of Understanding between Cook Native American Ministries and the Synod of the Southwest, including its four presbyteries, regarding the transition of the CRE training program (which had been coordinated by the former Cook School) from Cook Native American Ministries to the Synod.

In an action taken while convened as the Trustees of the Presbytery, approved the sale of the House of Neighborly Service property for the value of \$1.00 to the YWCA Southern Arizona, with stipulations addressing PILP loan repayment requirements, provided that MFA approves the terms of sale.

Approved calling a special meeting of Presbytery de Cristo on May 30, 2015, at a location to be determined, for the purpose of acting on proposed actions regarding the House of Neighborly Service.

## Actions taken at the May 27, 2015 meeting

Approved moving administration of the Middle Eastern Presbytery Fellowship (MEFP) from the Synod of the Southwest to Presbytery de Cristo.

In an action taken while convened as the Trustees of the Presbytery, approved a \$40,000 PILP loan (Fifty Million Loan Fund loan) to Divine Grace Presbyterian Church in Miami, with repayment over 5 years, to repair deficiencies in the church structure; and approved guaranty of the loan, subject to receiving a positive risk assessment from MFA.
